NSF has processed the application for Registration of **ZERO IN FOOD SERVICE FLYING INSECT KILLER** to the *NSF Registration Guidelines for Proprietary Substances and Nonfood Compounds (2003)*, which are available at www.nsf.org/usda. The NSF Nonfood Compounds Registration Program is a continuation of the USDA product approval and listing program, which is based on meeting regulatory requirements including FDA 21 CFR for appropriate use, ingredient and labeling.

This product is acceptable as a pesticide for use in all areas of official establishments operating under the Federal meat, poultry, shell egg grading, and egg products inspection programs (F1). Compounds used at dilutions containing more than one percent synergists must be dispensed as an aerosol spray in edible product areas. Compounds used at dilutions containing more than five percent combined synergists may not be dispensed in edible product areas.

Before using this pesticide compound, exposed food products and packaging materials must be removed from the room or protected. After using this compound, equipment and utensils must be washed with an effective cleaning compound and thoroughly rinsed with potable water before operations are resumed. Before food products may be placed in the area where the material is being used, the area should be sufficiently free of odor to prevent product contamination.

NSF Registration of this product is current when the NSF Registration Number, Category Code, and Registration Mark appear on the NSF-approved product label, and the registered product name is included in the current NSF White Book Listing of Nonfood Compounds at the NSF website (<http://www.nsf.org/usda>).
