Functional Unit

The functional unit is one seat for one individual, maintained over a 10-year period, including packaging materials used for the final assembled product. The product has met ANSI/BIFMA X5.4 requirements for a 10-year lifetime, so no replacements are required. To meet the functional unit, 1 unit of Rockwell Unscripted High Back Chair is required.

Reference Flow and Product Specifications

One Rockwell Unscripted High Back Chair (product code UELHCO with Fabric Upholstery) with wood legs and fabric upholstery was modeled for this EPD. This chair is determined to be a representative product based on sales of the variations. The results in this EPD are only representative of this configuration. While the exact configuration purchased may be slightly different, it is expected to have impacts within 10% of this representative configuration. 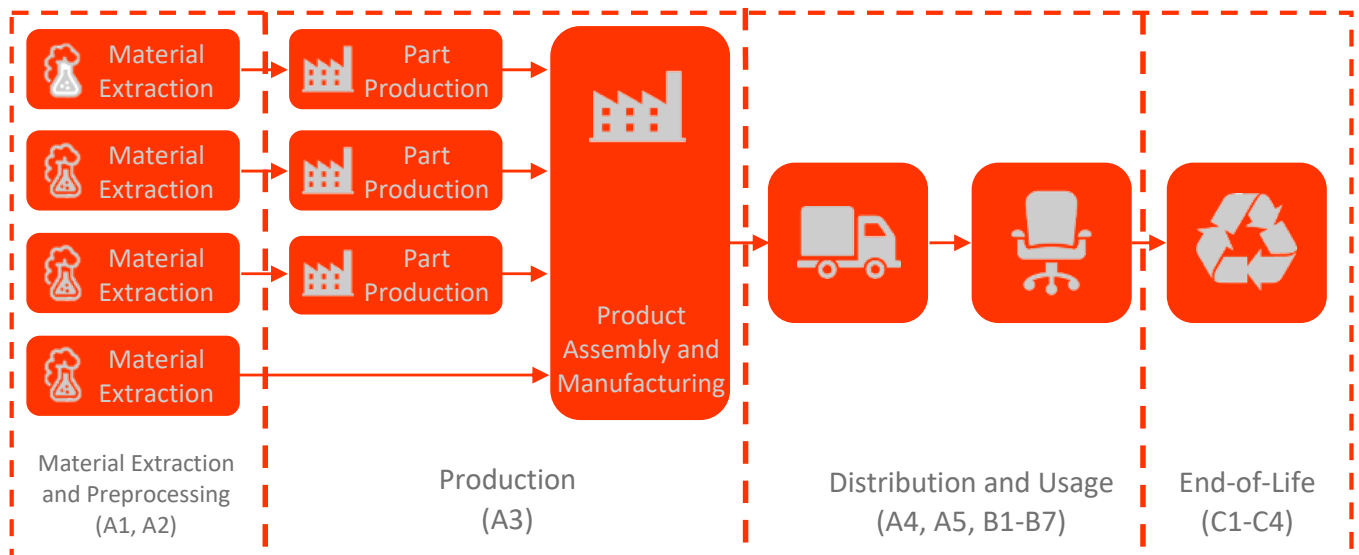
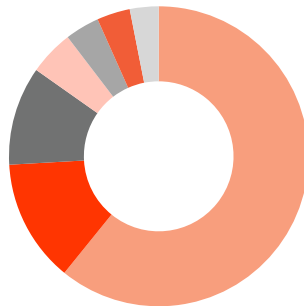

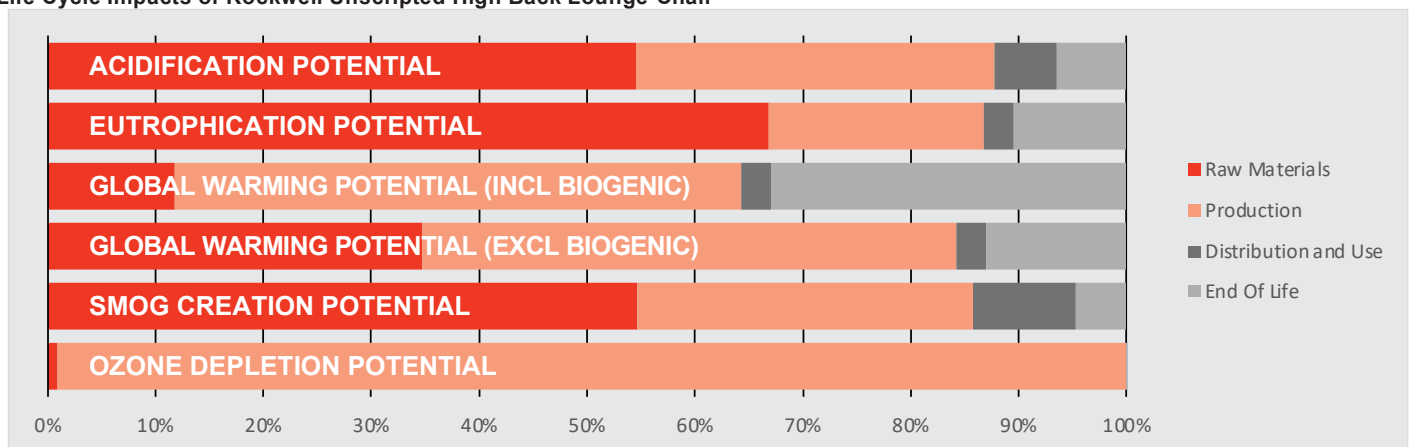
