The NSF Nonfood Compounds Registration Program is a continuation of the USDA product approval and listing program, which is based on meeting regulatory requirements for appropriate use, ingredient and labeling review.

This product is acceptable for use as a cleaner for use in soak tanks or with steam or mechanical cleaning devices (A2) in and around food processing areas, where its use is not intended for direct food contact. Use of this product in food processing or handling facilities requires that all food products and packaging materials be removed or protected prior to product use. A potable water rinse of cleaned surfaces is required after use of this product. When used according to manufacturer's instructions, the cleaner shall neither exhibit a noticeable odor nor leave a visible residue.

This product is acceptable for use as an ingredient in cleaning products to be used in and around food processing areas (AX) where its use is not intended for direct food contact. The acceptable use level will vary based on the ingredients in the remainder of the formulation. Most use levels generally used for the purpose in industry would be acceptable.

Formulations containing NSF Registered ingredients are not considered to be NSF Registered products. A separate application is required for each final product. Formulators using NSF Registered ingredients need only identify the trade name, the NSF Registration Number, and concentration within the finished product on the application form.
