Use of this product in food processing or handling facilities requires that all food products and packaging materials be removed or protected prior to product use. A potable water rinse of cleaned surfaces is required after use of this product. When used according to manufacturer's instructions, the cleaner shall neither exhibit a noticeable odor nor leave a visible residue.

This product is acceptable for use as a scouring cleaner (A6) in and around food processing areas. All odors or abrasive residue must be removed prior to using the cleaned surface for direct food contact.
