A potable water rinse of cleaned surfaces is required after use of this product. When used according to manufacturer's instructions, the cleaner shall neither exhibit a noticeable odor nor leave a visible residue.**

**This product is acceptable for use as an ingredient in cleaning products to be used in and around food processing areas (AX) where its use is not intended for direct food contact. The acceptable use level will vary based on the ingredients in the remainder of the formulation. Most use levels generally used for the purpose in industry would be acceptable.**

Formulators using NSF Registered ingredients need only identify the trade name, the NSF Registration Number, and concentration within the finished product on the application form.**
