NSF has processed the application for Registration of **Dyecclean 200** to the NSF International Registration Guidelines for Proprietary Substances and Nonfood Compounds (2013), which are available upon request by contacting [NonFood@nsf.org](mailto:NonFood@nsf.org). The NSF Nonfood Compounds Registration Program is a continuation of the USDA product approval and listing program, which is based on meeting regulatory requirements including FDA 21 CFR for appropriate use, ingredient and labeling review.

**This product is acceptable for use as a paint remover (C3) for use in areas where edible products are neither processed nor stored in open containers. Equipment and utensils which directly contact edible products must be thoroughly cleaned and rinsed with potable water after treatment with such products before being returned to a processing area.**

**This product is acceptable for use as a cleaner and degreaser for use in non food processing areas (K1), which are used to remove oil, wax, resinous materials, or other substances not removable by using acidic or alkaline cleaning agents. Their use is limited to nonprocessing areas where there is no possibility of solvent vapors entering a processing area. Food processing equipment or utensils treated with such preparations must be washed with an acceptable detergent solution and thoroughly rinsed with potable water before returning to a processing area.**

**This product is acceptable for use as an adhesive or glue remover (K3), for removing adhesive or glue from food packaging materials in and around food processing areas, where its use is not intended for direct food contact. Before using this compound, food products and packaging materials must be removed from the area or carefully protected. After using these compounds, all surfaces must be thoroughly washed with an acceptable detergent solution, and rinsed with potable water. This compound must be used in a manner so that all odors associated with the compound are dissipated before food products or packaging materials are re-exposed in the area.**
