Limitations: This ingredient is to be used in accordance with good manufacturing practices; it is not to exceed the minimum amount required to achieve the desired technical effect.. Formulations containing NSF Registered ingredients are not considered to be NSF Registered products. A separate application is required for each final product. Formulators using NSF Registered ingredients need only identify the trade name, the NSF Registration number, and concentration within the finished product on the application form.
