When used according to manufacturer's instructions, the cleaner shall neither exhibit a noticeable odor nor leave a visible residue.

This product is acceptable as a floor and wall cleaner (A4) in and around food processing areas, where its use is not intended for direct food contact. Use of this product in food processing or handling facilities requires that all food products and packaging materials be removed or protected prior to product use. A potable water rinse of cleaned surfaces is required after use of this product. When used according to manufacturer's instructions, the cleaner shall neither exhibit a noticeable odor nor leave a visible residue.

This product is acceptable as a hand washing compound for use in official establishments operating under the Federal meat, poultry, shell egg grading, and egg products inspection programs (E1).

The compound must be dispensed from adequate dispensers located a sufficient distance from the processing line to preclude accidental product contamination. After the use of the compound, the hands must be thoroughly rinsed with potable water. Under condition of use, there can be no odor or fragrance left on the hands.
