This compound must be used in a manner so that all odors associated with the compound are dissipated before food products or packaging materials are re-exposed in the area.**

**"This product is acceptable for use as an ingredient in cleaning products to be used in and around food processing areas (AX) where its use is not intended for direct food contact. The acceptable use level will vary based on the ingredients in the remainder of the formulation. Most use levels generally used for the purpose in industry would be acceptable.**

**Formulations containing NSF Registered ingredients are not considered to be NSF Registered products. A separate application is required for each final product. Formulators using NSF Registered ingredients need only identify the trade name, the NSF Registration Number, and concentration within the finished product on the application form."**
