If used as an anti-rust film, the compound must be removed from the equipment surface by washing or wiping, as required to leave the surface effectively free of any substance which could be transferred to food being processed. The NSF Nonfood Compounds Registration Program is a continuation of the USDA product approval and listing program, which is based on meeting regulatory requirements including FDA 21 CFR for appropriate use, ingredient and labeling review.

This product is acceptable for use as a soluble oil (H3). The product is used to prevent rust on hooks, trolleys and similar equipment. Treated equipment which contacts edible products shall be cleaned by washing or wiping before putting the equipment back into service.
